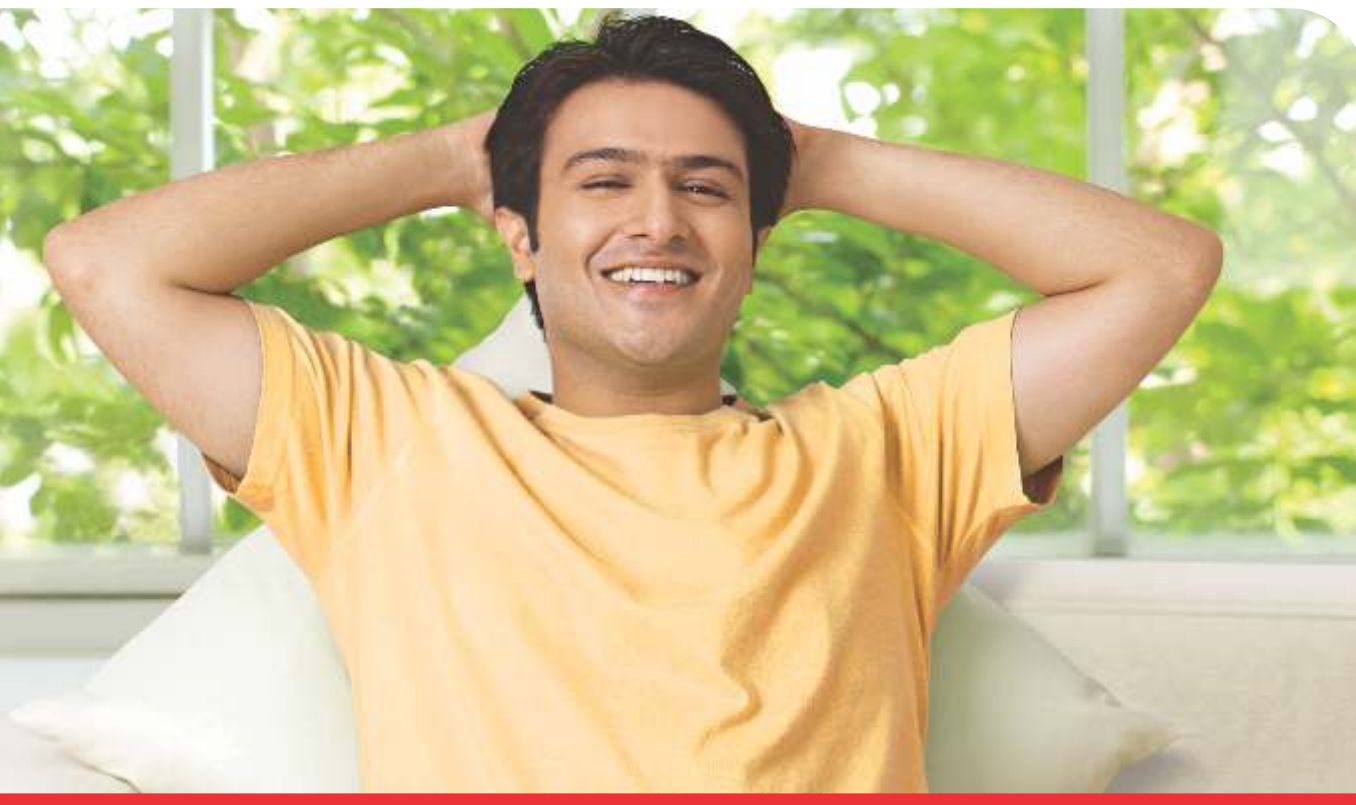

### What Exide Life Secured Income Insurance Plus is all about?

We all wish to save money for many financial goals like buying a car, building a house, child's education and marriage, retirement, etc. With multiple saving channels available, it is often confusing to assess which is really the best way to save. Any ideal savings plan must have the following essentials:

- Systematic and disciplined method of saving,
- Safe returns,
- Protection against any emergency or unavoidable circumstance, and
- Flexibility to customize the plan as per individual need.

Exide Life Secured Income Insurance Plus brings all of the essentials to you in one package. This plan is your ideal savings tool for long term financial goals. In addition to ensuring systematic savings it also ensures financial protection for your family in case of any unfortunate and unforeseeable event.

This product is oriented towards combination of savings as well as protection. This is a participating endowment assurance plan which means that Exide Life Insurance will invest money on your behalf and you will have a share in the profits of company's participatory fund which comes to you through bonuses declared by the Company. This plan is best suited for anyone who wants moderate but steady and guaranteed returns and is generally of risk averse nature.

### How the plan works?

Step 1	Choose the Policy Term, Premium Paying Term, Sum Assured and premium payment frequency
Step 2	Based on the chosen parameters and your age, the premium will be arrived at
Step 3	In case of unfortunate demise, Death Benefit will be paid. In case of maturity of the policy, Maturity Benefit will be paid.

\*For monthly mode, 3 monthly premiums will be required to be paid on the commencement of the policy.

## Plan benefits

### Death benefit:

In case of death of the life assured, the death benefit will be **Guaranteed Death Benefit + Vested Bonus, if any + Terminal Bonus, if any** subject to policy being in force.

Under all circumstances, the Death Benefit will never be less than 105% of total premiums paid till date of death excluding service tax and extra premiums paid, if any.

### Guaranteed death benefit :

Guaranteed Death Benefit is higher of Sum Assured or 10 times the annualized premium excluding service tax and extra premium paid, if any.

You will have the following options of receiving the Guaranteed Death Benefit:

**Option A:** Take the whole guaranteed death benefit as lump sum, or

**Option B:** Take the guaranteed death benefit as part lump sum and part as family income benefit.

In the event of choosing Option B on the unfortunate demise of the life assured, the family not only gets the a lump sum amount but also gets an assured income for next 5 years (which is payable on a monthly basis) as Family Income Benefit.

### Lump sum benefit:

If you choose option A, 100% of Guaranteed Death Benefit will be paid as lump sum.

If you choose option B, 50% of Guaranteed Death Benefit will be paid as lump sum.

Family Income Benefit: We understand that in case of unfortunate demise of the bread earner, the family can face financial difficulties. A regular income at this stage can really provide much needed security to your family. If you choose option B, Exide Life will pay 60% of Guaranteed Death Benefit in equal installments every month for 60 months following the death of the life assured. If you choose option A, Family Income Benefit is not payable. The first installment of Family Income Benefit will be paid immediately on unfortunate demise of the life assured.

Vested bonus, if any and terminal bonus, if any are paid in lump sum on death.

If age of the life assured is greater than or equal to 12 years, the risk cover under the policy will commence immediately from the date of commencement of the policy. If the age of the life assured is less than 12 years, the risk cover under the policy will commence from two years from completion of two policy years. During this period, if the Life assured dies, all premiums paid will be refunded without any interest.

Maturity Benefit: Exide Life values the faith that you have put in to us and to demonstrate the same, Exide Life Secured Income Insurance Plus provides 10% additional guaranteed Sum Assured on maturity of the policy. The total maturity benefit is as follows:

Subject to the payment of all the due premiums, the Maturity Benefit will never be less than 105% of all the premiums paid.

Flexibility to pay premiums for a shorter duration while enjoying benefits for longer duration: For those who have cyclical income or would like to make commitment for a shorter time while enjoying the plan benefits for the full duration, Exide Life Secured Income Insurance Plus provides limited Premium Paying Terms. You can choose to pay premium for 5, 7 or 10 years as per your convenience. While paying the premium only for the premium payment term chosen, your plan benefits will continue for the entire policy term which could be 10 to 20 years.

### Enhanced Protection Benefit through optional riders:

This plan offers the flexibility of customizing protective cover by opting for following riders by paying small amount of extra premium. Riders can be added at the inception of the Policy or at policy anniversary during the policy term subject to underwriting and terms & conditions of the riders.

Following riders are available with Exide Life Guaranteed Income Insurance Plan

- Exide Life Critical Illness (4) Regular Pay (UIN: 114B009V02)

Either one of Exide Life Critical Illness (4) Regular Pay or Exide Life Critical Illness (25) Regular Pay can be chosen.

Under any circumstance, rider sum assured of each rider cannot be more than base policy sum assured on death.

## Other benefits:

### Bonus:

Bonuses represent your share in the profits of company's participating fund. Bonus is calculated on the Sum Assured in the policy. Bonuses are therefore not guaranteed and are based on fund's performance. Exide Life Secured Income Insurance Plus provides two kinds of bonuses:

- **Simple reversionary bonus:** Exide Life may declare bonus as a percentage of Sum Assured which will be attached to your policy and will be paid at death or maturity of the policy whichever is earlier.
- **Terminal Bonus:** Exide Life may also declare a terminal bonus from 10th policy year and is payable at maturity of policy or death of the life assured.

Exide Life has declared healthy bonuses in the past and will endeavor to do so in the future. The track record of bonus for Exide Life's all products is available for reference on the Company website.

### Loan benefit

A life insurance policy should be handy for you in case of any adverse financial emergencies and this policy is designed to meet just that, whereby you can avail a policy loan as eligible once the policy attains surrender value.

### Income tax benefit

Policyholder may be eligible for tax benefits under section 80C and section 10(10D) of the Income Tax Act, 1961, subject to provisions contained therein.

- U/S 80C of the Income Tax Act 1961 on your premiums
- U/S 10(10D) of the Income Tax Act 1961 on the maturity proceeds of your policy\*
- U/S 80 D of Income Tax Act 1961 on the premium paid towards critical illness rider, if opted for

### Discount for high premiums

With Exide Life Secured Income Insurance Plus, we reward you with a premium discount if you pay higher premiums. The applicable premiums slabs and discount rates are mentioned below:

## Terms and conditions

### Grace period:

Grace Period is an extra time period after the premium payment due date which is provided to you for your convenience in paying the premium. Grace period is 30 days for annual premium payment frequency and 15 days for monthly premium payment frequency.

### Lapse:

If the Regular Premium is not paid within the grace period, the Policy shall lapse and have no further value except as described below.

If at least one full year's premium has been paid and less than two full years' premiums have been paid for policies with premium payment term of 5 or 7 years and less than three full years' premiums have been paid for policies with premium payment term of 10 years, the nominee will be eligible for death benefit which will be equal to surrender value as applicable and the Policy terminates.

### Reduced paid up:

If at least two full years' premiums have been paid for policies with Premium Payment Term of 5 or 7 years and if at least three full years' premiums have been paid for policies with Premium Payment Term of 10 years and further premiums are unpaid and the policy is not surrendered, the policy will acquire a reduced paid up state on the date of expiry of grace period. Once the policy becomes reduced paid up, the sum assured will be reduced as per the formula mentioned below:

## For maturity benefit

$$\text{Reduced Paid-Up Sum Assured} = \frac{\text{Number of premiums paid}}{\text{Total Number of premiums payable}} \times (110\% \text{ Sum assured of basic policy}) + \text{Accumulated Bonus, if any}$$

## For death benefit

$$\text{Reduced Paid-Up Sum Assured} = \frac{\text{Number of premiums paid}}{\text{Total Number of premiums payable}} \times (\text{Sum assured of basic policy}) + \text{Accumulated Bonus, if any}$$

In case of death of life assured during this period, the above mentioned benefit will be payable only as lump sum whether the Guaranteed Death Benefit is chosen as option A or option B.

A reduced paid up policy will not be eligible for bonuses declared after premium discontinuance.

### Reinstatement:

Policy can be reinstated during the policy term but within a period of two years from the date of first unpaid premium by submitting the proof of continued insurability to the satisfaction of the board approved underwriting policy and making the payment of all due premiums together with interest / payment of reinstatement charge at such rate as may be prevailing at the time of the payment. If needed the company may refer it to its medical examiner in deciding on reinstatement of lapsed policy.

### Surrender:

In order to honour unexpected commitments or needs, a Surrender option is available. This policy can be surrendered if at least one full year's premium is paid. The surrender benefits are payable immediately on surrender or at the end of the second policy year, whichever is later. All benefits under the policy shall automatically terminate upon payment surrender benefit.

The surrender benefit is higher of the Special Surrender Value (SSV), if any or the Guaranteed Surrender Value (GSV), after deduction of any loans under the Policy. GSV and SSV are as follows:

### Guaranteed surrender value (GSV):

If at least one full year's premium has been paid, the policy acquires a GSV. GSV depends on the year of Surrender. GSV is the sum of the following:

- GSV Factor 1 multiplied by the total amount of premiums paid excluding the applicable taxes and premium for extra mortality rating, if any.
- GSV Factor 2 multiplied by the total vested bonus accrued to the policy, if any.

The GSV Factors increase with the policy duration and are provided in the table below:

\* If at least two full years' premiums have not been paid for Policies with Premium Payment Term of 5 or 7 years and if at least three full years' premiums have not been paid for Policies with Premium Payment Term of 10 years, then the applicable GSV Factor 1 would be fixed 20% and GSV Factor 2 would be fixed 0%; irrespective of the policy year in which the policy is surrendered.

### Special surrender value (SSV):

If at least two full years' Premiums have been paid for Policies with Premium Payment Term of 5 and 7 years and if at least three full years' Premiums have been paid for policies with Premium Payment Term of 10 years, the policy may acquire a Special Surrender Value. SSV, at no point of time, will be lesser than the GSV. SSV will be declared by Company from time to time.

For e.g. for a policyholder with entry age of 35 years; Premium of ₹36,000 annually; Policy Term of 20 years, premium payment term of 10 years and Sum Assured of ₹2,97,250, the surrender value (assuming that he has paid 7 premiums and surrenders at the end of 7th policy year and assuming that simple reversionary bonus of 7% p.a. has been declared since policy inception) is calculated as follows:

GSV as a percentage of premiums paid = 50% of all the premiums paid = 50% of (₹36,000 × 7) = ₹1,26,000, plus

GSV as a percentage of vested bonus = 15% of vested bonus = 15% of (₹2,97,250 × 7% × 7 years) = ₹21,848.

Total GSV = ₹1,26,000 + ₹21,848 = ₹1,47,848

SSV = Applicable SSV factor × Sum Assured + Vested Bonus/1000 = 423.41 × (₹2,97,250 + ₹1,45,653)/1000 = ₹1,87,530.

The surrender value is higher of GSV or SSV and hence is equal to ₹1,87,530.

All benefits under the policy shall automatically terminate upon payment of Surrender Value.

### **Free look period:**

In case you disagree with any of the terms and conditions of the policy, you have the option to cancel the policy by writing to the company stating the reasons for disagreement with the policy terms and conditions and return the original policy document to the company within 15 days of the receipt of the Policy Document. In case of such cancellation, the premiums you have paid will be refunded after deducting the medical examination fees (if any), stamp duty charges and proportional charges towards Insurance risk cover. In case the policy is sourced through Distance Marketing# the free look period is 30 days from the receipt of the policy document.

#Distance Marketing includes solicitation through all modes other than in person.

### **Suicide:**

If the Life Assured commits suicide for any reason whether sane or insane within one year from date of commencement of risk or within one year from the date of reinstatement of the policy, the company will not be liable to pay the benefits under the policy other than what is specified below:

Death occurs within one year from date of commencement: 80% of premium paid, excluding Service Tax.

Death occurs within one year from date of reinstatement: Higher of 80% of Premium paid excluding service tax or Surrender Value as available as on the date of death.

### **Assignment:**

Assignment should be in accordance with provisions of sec 38 of the Insurance Act 1938 as amended from time to time.

### **Nomination:**

Nomination should be in accordance with provisions of sec 39 of the Insurance Act 1938 as amended from time to time.

### **Other provisions:**

The policy can be proposed by the natural parents or legal guardian, who has an insurable interest on the child. In case of death of the proposer during the minority of the Life Assured, the premiums can continue to be paid by the natural parents or legal guardian, who has insurable interest in the child and the policy will continue. In case no further premiums are being paid the normal policy norms are applicable and the proceeds of the policy, if any, shall be payable to the legal guardian of the minor.

In the event of death of the Eligible Person (nominee or legal heir of the Life Assured) the present value of the outstanding Family Income Benefit as determined by the Company under this policy will be paid as a lump sum to the legal heirs of the Eligible Person.

The information herein is indicative of the terms, conditions, warranties and exceptions contained in the policy terms and conditions of Exide Life Secured Income Insurance Plus. ## Section 41: Prohibition of Rebate

Under the provisions of Section 41 of the Insurance Act, 1938

- (1) No person shall allow or offer to allow, either directly or indirectly, as an inducement to any person to take or renew or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of the whole or part of the commission payable or any rebate of the premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate, except such rebate as may be allowed in accordance with the published prospectuses or tables of the insurer:
- (2) Any person making default in complying with the provisions of this section shall be punishable with fine which may extend to ten lakh rupees.

### Fraud, Misrepresentation and forfeiture:

Fraud, Misrepresentation and forfeiture would be dealt with in accordance with provisions of Sec 45 of the Insurance Act 1938 as amended from time to time.

### Section 38 - Assignment and Transfer of Insurance Policies:

Assignment or transfer of a policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

01. This policy may be transferred/assigned, wholly or in part, with or without consideration.
02. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.
03. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
04. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
05. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy there of certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
06. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
07. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
08. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.
09. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
  - a. not bonafide or
  - b. not in the interest of the policyholder or
  - c. not in public interest or
  - d. is for the purpose of trading of the insurance policy.
10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of policyholder giving a notice of transfer or assignment.
11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
  - a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR
  - b. where the transfer or assignment is made upon condition that
    - i. the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of assignee or transferee dying before the insured OR
    - ii. the insured surviving the term of the policy

Such conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.
14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
  - a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
  - b. may institute any proceedings in relation to the policy
  - c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Laws (Amendment) Ordinance, 2014 shall not be affected by this section.

**Section 39 - Nomination by policyholder:**

Nomination of a life insurance policy should be in accordance with Section 39 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

01. The policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.
02. Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment to be laid down by the insurer.
03. Nomination can be made at any time before the maturity of the policy.
04. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.
05. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.
06. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.
07. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
08. On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a nomination or cancellation or change thereof.
09. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.
11. In case of nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).
13. Where the policyholder whose life is insured nominates his
  - a. parents or
  - b. spouse or
  - c. children or
  - d. spouse and children
  - e. or any of them

the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.
14. If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).
15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Laws (Amendment) Ordinance, 2014 (i.e 26.12.2014).
16. If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.
17. The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where before or after Insurance Laws (Ordinance) 2014, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.

**Section 45 - Policy shall not be called in question on the ground of mis-statement after three years:**

Provisions regarding policy not being called into question in terms of Section 45 of the Insurance Act, 1938, as amended from time to time. The extant provisions in this regard are as follows:

01. No Policy of Life Insurance shall be called in question **on any ground whatsoever** after expiry of 3 yrs from
  - a. the date of issuance of policy or
  - b. the date of commencement of risk or
  - c. the date of revival of policy or
  - d. the date of rider to the policy
 whichever is later.
02. On the ground of fraud, a policy of Life Insurance may be called in question within 3 years from
  - a. the date of issuance of policy or
  - b. the date of commencement of risk or
  - c. the date of revival of policy or
  - d. the date of rider to the policy
 whichever is later.
 

For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.
03. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy:
  - a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;
  - b. The active concealment of a fact by the insured having knowledge or belief of the fact;
  - c. Any other act fitted to deceive; and
  - d. Any such act or omission as the law specifically declares to be fraudulent.
04. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak or silence is in itself equivalent to speak.
05. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the policyholder, if alive, or beneficiaries.
06. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the policy of life insurance is based.
07. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on policy till the date of repudiation shall be paid to the insured or legal representative or nominee or assignees of insured, within a period of 90 days from the date of repudiation.
08. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance policy would have been issued to the insured.
09. The insurer can call for proof of age at any time if he is entitled to do so and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
